## Information on free all-day schools

### DEAR PARENTS,

On 24 June 2020, the Vienna City Council decided to eliminate fees for all-day public primary schools and lower-secondary schools (with classes in the morning and in the afternoon) run by the City of Vienna.

Based on this decision, the Vienna Schools Department (MA 56) would like to provide you with the following practical information:

- For children attending all-day schools run by the City of Vienna, you do not have to pay any day-care fees for care during core hours and any meal fees for lunches.
- The elimination of fees does not apply to open-learning strands/classes (*offene Stränge/Klassen*) offered at all-day schools. As teaching is limited to the morning in such strands/classes, fees have to be paid for day care and meals.

### FEES FOR AFTER-HOURS CARE AND AFTERNOON SNACKS

Fees for after-hours care (*Spätbetreuung*) and afternoon snacks (*Jause*) provided at all-day schools are laid down as follows:

- If you register your child for voluntary after-hours care (after the eighth unit of instruction at primary schools and after the ninth unit of instruction at lower secondary schools), you have to pay a moderate parents' contribution. The flat rate per semester is EUR 127 in the school year 2025/26.
- If the majority of parents wishes that children attending an all-day school get an afternoon snack at their school, you have to pay a flat rate totalling EUR 333 for the school year 2025/26. This flat rate will be billed in three instalments.
- If you receive means-tested basic benefits (*Mindestsicherung*), equalisation supplements (*Ausgleichszulage*) or basic welfare support (*Grundversorgung*), you are exempt from the flat rates mentioned above. Evidence of receipt of those benefits (official notice or confirmation – *Bescheid* or *Bestätigung*) has to be provided to the school when you register your child at the start of the school year or semester. Exemption from the flat rates is only possible for payers having their primary residence in Vienna.
- If you register your child for afternoon snacks, this registration is **binding**. This registration is only possible at the **start of the school year** and is **effective for the entire school year**.
- Registration/deregistration for **after-hours care** is only possible at the **start of the school year/semester**, and if you register/deregister your child, this registration/deregistration is **binding**.
- Registration for afternoon snacks/after-hours care has to be made **in writing** by completing the relevant registration form (*Anmeldeformular Jause Spätbetreuung*) and submitting it to the school.

As the amounts to be paid are flat rates, refunds are **not** possible.

Please note that considerable additional costs will arise if you do not pay the amounts billed in time. Moreover, if you fail to pay flat-rate amounts for afternoon snacks and/or after-hours care, these additional service(s) will be immediately discontinued for your child. These service(s) can only be used again after you have fully paid the total amount owed.
